### Filing Instructions

In order to begin processing a no-fault arbitration case, the American Arbitration Association (AAA) requires the following be filed with the AAA, pursuant to Minnesota No-Fault Arbitration Rules 5(c) and 5(e):

1. **Filing Fee:** A \$ 60.00 filing fee payment made payable to American Arbitration Association.
2. **Petition:** A completed Petition for No-Fault Arbitration, signed by the claiming party or representative.
3. **Denial/Discontinuation Letter:** A letter from the insurance company verifying that benefits have been denied or discontinued. If a denial letter has not been provided, please include this information with your submission.
4. **Itemization of Claim:** An itemization detailing what you are claiming for arbitration. If filing for unpaid medical bills, the itemization should include the name(s) of medical providers, the name(s) of employer(s), date(s) of service or loss and the amount(s) claimed for each. If filing for property damage, the itemization should include repair estimates. If your vehicle is a total loss, include any valuation reports.
5. **Supporting Documents: Documentation supporting your claim.** e.g. billing summaries, wage stubs, repair receipts, market value comparisons, etc.
